Dear Secretary Duffy:

We are writing to encourage the U.S. Department of Transportation (USDOT) to support the inclusion of \$2.024 billion in the President's Fiscal Year 2027 Budget Request for mobility initiatives for the 2028 Olympic and Paralympic Games (the Games). This funding will ensure that the Los Angeles County Metropolitan Transportation Authority (Metro) and our regional partners, can successfully institute the world-class mobility plan for the Games.

The lead time needed to plan for an event of the scale and scope of the 2028 Games means that the President's Fiscal Year 2027 Budget Request will likely be the final opportunity to ensure that federal transportation funding can be made available in a timely manner in advance of the Games.

As has been noted by Metro and many others, these Games will be the largest and most spectacular sporting event in American history, providing an unparalleled opportunity to showcase America to the world. The Games will primarily take place at multiple locations across Los Angeles County, with several events also being held across Southern California and in Oklahoma. Approximately 15 million ticketholders are projected to attend from around the world, contributing a projected \$18 billion to the U.S. economy. Like you, we collectively want to ensure that we have a safe, secure, efficient, and accessible transportation network in the Los Angeles mega-region for this global sporting event. We are convinced that delivering on this goal will require the full support of the Federal Government.

Thank you for considering this request. We look forward to working with the U.S. Department of Transportation to ensure the 2028 Games reflect the very best of our great nation and serve as an example for the world. Working together, we are convinced that Metro and our regional partners can implement a safe, secure, efficient, and accessible transportation plan for the 2028 Games that will make America the envy of the world.






